





Description

Sika is a specialties chemical company with 2 divisions. The construction division makes about 80% of sales. It offers cement additives which improve cement qualities such as elasticity, impermeability, drying time in wet or cold condition, faster or slower drying. Sika also produces roofing membranes and coating for basements and floors in buildings such as factories or hospitals. Sika sealants and components are used to strengthen structures (bridges, tunnels) and to build glass walls.

The automotive division, makes about 20% of sales. Its main products are used to seal windcreens and windows on cars, busses, trucks and trains. Sika materials are also used to strengthen car bodies; phonic foams are aimed at damping noises inside the vehicle.






Sales growth




EBITDA




Variation WC
